2017 PRIMARY THREE LEVEL-WIDE SCHOOL PROGRAMMES

1. The school has planned level-wide school programmes for your child/ward to develop and maximise her potential. The school will be subsidizing fully some of these activities and programmes e.g. Cultural Camp, MOnline Learning Management System (LMS) and pupil insurance. For other programmes, the school has a co-payment policy due to limited funds and resources, and these can be paid for through Edusave withdrawals and cash/cheque payments.

3. Please complete the attached forms and return them, together with your payment of \$10 (if any) to your child's / ward's form teacher, by **Monday 16 January**. Singaporean pupils can pay the amount from their Edusave account. Pupils without Edusave accounts (Singapore PRs and International Students) or Singaporeans who do not wish to use the funds in their Edusave accounts will pay \$10 in cash or cheque payable to "Ministry of Education". The cash/cheque should be attached to the reply slip and submitted to your child's/ward's Form Teacher by **Monday, 16 January**.

For Singapore citizens: If you have given your authorisation for the Edusave Enrichment Programme Standing Order (EPSO) via the Standing Order for Use of Edusave Account in 2016, the school will proceed to deduct **\$10.00** (after school subsidy) from your child's/ward's Edusave account.

However if you have not given and do not wish to give your authorisation for EPSO, please pay **\$10.00** (after school subsidy) in cash or issue a cheque payable to "Ministry of Education".

For Singapore Permanent Residents and International Students: please pay **\$10.00** (after school subsidy) in cash or issue a cheque payable to "Ministry of Education".

4. Consent for your child/ward to attend the above programmes will be sought at a later date. A refund will be made if you do not consent to your child attending the programme. There will be no refund if you have given your consent but your child/ward is subsequently absent for the programme without a valid reason e.g. medical certificate.
5. Collections may still be required for other programmes planned for the year, if there is any. More details will be disseminated later.
